No. SPP-2020/C.R.37/D-XIV :- In Continuation of Notification No. SPP-2020/C.R.37/D-XIV, dated 4th March, 2020, in exercise of the powers conferred under 32 (1) of The Protection of Children from Sexual Offences Act (POCSO), 2012 (No. 32 of 2012), the Government of Maharashtra hereby designate the following Additional Public Prosecutors at Sessions Court in the following Districts in Maharashtra, as Exclusive Special Public Prosecutors to conduct the cases before the Special POCSO Courts (Fast Track Special Courts) constituted under Government Resolutions No. FTC1419/5/ C.R.No.04/Desk 09, Dated 04.03.2020, 13.05.2020, 13.08.2020 and 05.04.2021 of Law and Judiciary Department and orders dated 25.07.2019 and 08.01.2020 passed by the Hon'ble Supreme Court of India in Suo-Moto Writ Petition (Criminal) No. 01/2019.
