Disposal of Old/Unusable/Obsolete/scrapped IT hardware in Mantralaya and vicinity of all department.

1. Introduction:

Sealed quotations are invited from listed agencies on Maharashtra Pollution Control Board website https://mpcb.gov.in for the dispose old/unusable/obsolete/ scrapped IT hardware items available in various departments of Mantralaya, Mumbai and vicinity offices.

2. Scope of Work:

Scope includes collecting & taking all materials from the sites (identified by the departments for e-waste) of Mantralaya and vicinity "as is where is basis" for disposal/recycling/reusing in line with Central/State Government guidelines. As of now, there are around 900 ICT devices and peripherals at Mantralaya and its vicinity which can be increased.

The Empanelled agencies should agree to the condition to "remove the storage media viz., Hard disk, Tapes, DATs, etc. and the same has to be degaussed in front of the department officials before lifting the E-Waste IT material from the Various Mantralaya departments and vicinity".

The price quoted should be only in Indian Rupees.

3. <u>Selection methodology:</u>

Department is wish to create empanelment of the agencies for the period of 1 year for the dispose old/unusable/obsolete/scrapped IT hardware items available in various departments of Mantralaya, Mumbai and vicinity offices. Empanelment would be done for the three agencies who will match the highest percentage quote among all the submitted quotes as per the Annexure 1. In case H2 and H3 not will to match H1 quote, H4 and H5 will be allow to match H1 quote for empanelment.

The Agency has to submit on percentage basis on upset value as per the GR issued by Directorate of IT on dated 01/08/2011 as decided by concern department of all the items separately, as mentioned material in Category A and Category B as per **Annexure 1**.

The Agency should alone bear the expenses like transportation, loading charges etc. for lifting of material.

The cost of the scrapped material while lifting from department should be inclusive of applicable GST.

The representative of the Agency can be present for the opening of the Bid. No separate intimation will be given in this regard to the Agency for deputing their representative. The bid will be opened in the presence of Agency's representative and DIT Officials.

4. **Period of Contract:**

- i. The empanelment will be valid for the period of ONE year from date of declared empanelment. Department/Office (List in Annexure 2) can directly select any of the empaneled agency for the disposal of their scrapped IT material.
- ii. DIT has right to review the contract during validity period and may terminate contract in any of the

following circumstances.

- iii. More than 5 working days delay in lifting of scrapped material for more than two time.
- iv. Denial to accept order from department/office
- v. In addition to the termination of empanelment, DIT will recommend MPCB to take appropriate action against the agency as per the their contract.

16. Tentative list of Scrap:

- i. As of now, there are around 900 ICT devices and peripherals at Mantralaya and its vicinity.
- ii. Mantralaya all departments' scraps will be consider in duration of one year.
