No. EST. 1091/(101)-Desk-III.—In exercise of the powers conferred by the wowiso to article 309 of the Constitution of India, the Governor of Maharashtra is pleased to make the following rules regulating recruitment to the posts of Director of Environment, Sciennist-Grade-I and Scientist-Grade-II in Class-I in the Environment Department of the Government of Maharashtra, namely:—

- I. (I) These rules may be called the Director of Environment, Scientist-Grade-II in the Environment Department (Recruitment) Rules, 1993.
- (2) They shall be deemed to have become in force with effect from the 1st

 - (a) " Commission " means the Maharashtra Public Service Commission;
 - (b) "degree" means a degree of a statutory university;
 - (c) " Environment Department " means the Environment Department of

Provided that, preference may be given to candidates having practical experience of working in. control of pollution and protection of environment such as effluent treatment, hazardous waste management, control of industrial and air pollution. of industrial and air pollution etc.

Provided further that, the age limit may be relaxed by Government on the recommendation of the Commission in favour of candidates possessing exceptional qualification or experience or both.

4. Appointment to the post of Scientist Grade-I in the Environment Department shall be made either,-

(a) by promotion of a suitable person on the basis of strict selection from amongst the persons holding the post of Scientist Grade II in Environment Department having regular service in that post for at least three years and possessing qualifications prescribed for appointment by nomination in sub-clauses (ii) and (iii) of clause (d) of this rule; or

(b) by transfer of a suitable officer holding an equivalent post in any other class-I service in any department of Government; or

 - (b) by transfer on deputation of a suitable officer from a local body or a statutory body under Government possessing qualifications and experience mentioned in sub-clauses (ii) and (iii) of clause (c) of this rule; or
 - (c) by nomination from amongst candidates who,-
 - (i) unless already in the service of Government are not more than thrity five years of age;
 - (ii) possess Master's degree in first class in pure Science of Civil or Mechanical Engineering or Chemical Engineering, Chemical Technology, Public Health Engineering or Environmental Engineering; and
 - (iii) possess experience of not less than five years, gained after acquiring, qualifications prescribed in sub-clause (ii) above, in a responsible position in or under a Government Department, or in a local authority or any statutory body under Government, or in the field of industry, or public health or urban development or public water supply and disposal of sewage or afforestation, having concern with control of pollution and protection of environment.

- 6. Appointment to the posts mentioned in rules (3) and (4) by promotion and nomination shall be made in the ratio of 50: 50.
- 7. A person appointed to the posts mentioned in rules 3, 4 and 5 by nomination shall be on probation for a period of two years.
- 8. A person appointed to the posts mentioned in rules 3, 4, and 5 shall be required to pass the examinations in Hindi and Marathi according to rules made in that behalf unless he has already passed or has been exempted from passing those examinations.
- 9. Notwithstanding anything contained in these rules, if in the opinion of Government the exigencies of service so require, Government may, after consultation with the Commission, wherever necessary, make appointments to the posts mentioned in rules (3) and (4) in relaxation of the percentage prescribed in these rules for recruitment by nomination and promotion.
