- 1) Deen Dayal Antoyodaya Yojana, National Rural Livelihoods Mission (DAY NRLM) is an ambitious mission mode programme launched by Ministry of Rural Development, Government of India for eradication of rural poverty. Maharashtra State Rural Livelihoods Mission (MSRLM) is established to implement National Rural Livelihoods Mission (NRLM). A special component under Deen Dayal Antoyodaya Yojana, National Rural Livelihoods Mission (DAY NRLM) is National Rural Livelihoods Project (NRLP), which is funded jointly by Government of India, IDA, IBRD & Government of Maharashtra. 4) Qualification criteria

- a. Copy of GST Registration certificate.

5) Quotation Price:-

- a. Each bidder shall submit only one quotation.
- b. Bidder shall not contract other bidder in matter relating to this Quotation.
- c. Conditional quotations which are not in line with this request for quotation shall be treated as non-responsive.
- d. Quotations must be submitted as per the attached format in a sealed envelope. Quotation in any other format and by any other means will not be accepted for evaluation.

9) Award of contract: -

- e. The SMMU-MSRLM will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- f. Notwithstanding the above, the SMMU-MSRLM reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

- g. The bidder whose quotation is accepted will be notified of the award of contract by the SMMU-MSRLM prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the Supply order.
